- (vii) Duly filled, signed and stamped form and appendix to form of tender.
- (viii) Properly filled, signed and stamped confidential business questionnaire.
- (ix) Signed tender security & declaration form.
- (x) Presentation of a well bound and properly paginated tender document (including attachments).
- (xi) Availability of stocks. Must be ex-stock and due diligence shall be undertaken at the point of evaluation.
- (xii) Availability of spare parts shall form part of the due diligence.
- (xiii) Excavators' engine must have capacity for a three-stage filter system.
- (xiv) All equipment must demonstrate high corrosion resistant coating.
- (xv) Manufacturer's Authorization/agency letter of dealership.
- (xvi) Compliance with submission both online through the **IFMIS System** and manually where **1 No.** hard copy must be submitted.
- (xvii) Any other condition as stipulated in the Tender Documents.
