- (iv) Tender security /bid bond amounting **to 2% of contract** sum in form of bank guarantee as per the form and format and should be valid for additional thirty **(30) days** after expiry of the tender validity period.
- (v) Certified Copy of Recent CR12 Form – (12months) from Registrar of Companies
- (vi) Certified copy of valid relevant certification from the Regulatory body.
- (vii) Duly filled, signed and stamped form and appendix to form of tender.
- (viii) Properly filled, signed and stamped confidential business questionnaire.
- (ix) Signed tender security & declaration form.
- (x) Presentation of a well bound and properly paginated tender document (including attachments).
