11. Properly filled, signed and stamped mandatory Bill of Quantities.
12. Duly filled confidential business questionnaire (attach CR 12 to confirm Directors)
13. Duly filled declaration form.
14. Proof of possession of major equipment owned or leased;
15. CV's and copies of qualification certificates of key site management and

technical personnel proposed for the Contract;

16. Audited accounts for the last Three years **(2022,2023,2024)** all the pages must be initialised and stamped by both a practising Auditor registered with ICPAK and one of the Directors
17. Bank statements for the last six months. The statements must be certified by the issuing bank on all pages
18. A pre-tender site visit certificate
19. Presentation of a well bound and properly paginated tender document (including the attachments).
20. Compliance with submission both online through the IFMIS system and manually where **1No. hard copy** must be submitted.
21. Any other condition stipulated in the tender document.
